'Capajet Flight Charter Agency' along with India based travel agency 'Trips Exotica' is planning to operate a special repatriation charter flight from Jakarta to Delhi on 17<sup>th</sup> July 2020.

This flight can be booked by **Indian Citizens and Overseas Citizen of India (OCI) card holders only**. Interested passengers may please visit the link given below and book the tickets.

The cost of the ticket is approximately USD 400 per adult for Economy Class and USD 1200 for Business Class plus transaction charges of 3.99%. Balance details will be provided in the link.

Each individual (parent/ guardian in case of minor) is to download, print, sign and scan an Undertaking form for each passenger giving their willingness to accept all terms and conditions of Govt of India paid institutionalized mandatory quarantine and Rapid/ Swab/ PCR Test as required at their own expense. The form is available on the Embassy website main page and it is advisable to first have the signed form ready and scanned as a PDF file to upload during the booking process.

# Kindly Note:

- Seats will be allotted on "First come first serve" basis as generated by the system/ payment link. It is unlikely that there will be additional special charter flights after this. Hence, individuals in urgent need for return to India in July 2020 or till such time regular commercial flights commence are advised to avail of this opportunity.
- Embassy of India, Jakarta is only facilitating the repatriation of stranded Indians through this charter and travel agency. The Embassy has no role in collection of payment, issue of e-tickets or refund issues that may arise related to this itinerary. All other terms and conditions of the booking, payment, cancellation or refund if any are to be dealt with directly between the individual and the agency for which their contact details are available in the booking form.
- The booking will only deemed to be confirmed if the Undertaking form is received correctly.
- As per available information about International airlines operating out of Indonesia, it is mandatory to have a COVID-19 Rapid Test/ PCR test with result 'non-reactive'/ 'negative' that has been undertaken not more than 72 hours prior departure of the flight. Any denial of boarding by the airline/ immigration authorities due to incomplete documents, non-availability of health/ COVID free certificate will not be the responsibility of the Embassy.
