TERMS AND CONDITIONS

- a. Firms / Company should have minimum experience of 03 years working in the field.
- b. The quotes shall be neatly arranged, plain and intelligible. It should mention that chemical proposed to be used, methodology of proposed treatment and guarantee period of treatment.
- c. The bidders shall visit the site before bidding to apprise themselves of the exact requirements relating to the scope of the work.
- d. The firms / companies concerned will be fully responsible for the safety and insurance of its employees.
- e. The rates should be valid for 120 days.
- f. The Consulate reserves the right to reject any or all bids/offers without giving any notice or assigning any reason thereof. The decision of the Consulate in this regard will be final and binding upon the bidders.
- g. Bid shall be tendered in lump-sum fixed price (excluding VAT) quoted in local currency (Indonesian Rupiah) only. The lump-sum fixed price is to be mentioned both in figures and in words.
- h. Taxes, if any applicable, are to be mentioned separately.
- i. If any information furnished by the bidder is found incorrect at a later stage, the firm / company shall be liable to be debarred from tendering. Consulate General of India, Medan reserves the right to verify the particulars furnished by the applicants independently.
- j. Price quoted by the bidder and agreed to by Consulate General of India, Medan shall be considered final and no price escalation will be permitted thereafter.
- k. Payment of 95% of total amount will be done after successful completion of work.
- l. Defect Liability Period of 6 months from the date of successful completion of work
- m. Payment of the balance 5% after a period of 06 months (Defect Liability Period) from the date of successful completion of work.
- n. The work is to be completed within forty five (45 days) after award of the work order.
